# Cotton Gin Time-of-Use Service Schedule CG-TOU-9

## **Availability**

Throughout the Corporation's service area from existing lines of adequate capacity.

## **Applicability**

Applicable to service used for the operation of cotton gins requiring more than 50 kVA of transformer capacity, subject to the established Service Rules and Regulations of the Corporation.

## **Type Of Service**

Single-phase or three-phase service, 60 Hertz, at available secondary voltages.

### **Annual Rate**

D. WPCA - The above rate charges shall be increased or decreased in accordance with the Corporation's Wholesale Power Cost Adjustment Clause.

## **Minimum Annual Charge**

The minimum annual charge shall be the sum of the Service Charge, Maximum Demand Charge, and On-Peak Demand Charge stated above.

The member's obligation to pay the full minimum annual charges herein shall not be diminished by discontinuing use of such service during September through August of the contract year (this twelve-month period is referred to herein as the "cotton gin contract year").

Any application for reconnection of service at any later date shall obligate the member to pay the sum of any accrued charges applicable to the cotton gin contract year during which service was disconnected.

### **Determination Of Maximum Demand**

The Maximum Demand shall be the highest 30-minute kW measurement in the current month, provided however, that the Maximum Demand shall not be less than the highest such demand established to date during the current cotton gin contract year, nor less than 75% of the member's required transformer capacity.

#### **Determination Of On-Peak Demand**

The On-Peak Demand shall be the average of the highest monthly 60-minute kW measurements during the on-peak hours in each of the four preceding months of June through September. The on-peak hours shall be the hours beginning 4:00 p.m. and ending 9:00 p.m. from June 1 through September 30 and will exclude weekends (Saturdays and Sundays).

This On-Peak Demand so determined shall be effective for monthly billing during the following October through December, according to the Terms of Payment provision set forth below.

### **Line Extension Cost**

The amount specified under the line extension and rephasing policy contained in the Service Rules and Regulations of the Corporation, such amount to be provided by the member in a manner specified in that policy.

### **Terms Of Payment**

Bills are due when rendered monthly. In the event the current monthly bill is not paid within fifteen days of the billing date, the bill becomes delinquent.

The Service Charge, Maximum Demand Charge, and On-Peak Demand Charge shall be billed in three equal monthly installments in October, November, and December of each year, whether or not energy is actually used during the cotton gin contract year.

A member, who contracts for service hereunder and service is rendered prior to September of the first year, will be billed for a prorated Service Charge, Maximum Demand Charge, and On-Peak Demand Charge based on the number of billing months between the availability of service and the next September. The prorating will be based on the number of days remaining in the cotton gin contract year and will be billed on the member's first statement rendered after service is available.

#### **Term Of Contract**

Contract term of service hereunder shall be based upon the investment required to provide service and the member's projected annual revenue.
