

Sumter Electric Membership Corporation

Irrigation Time-of-Use Service Schedule ITS-9

Availability

Throughout the Corporation's service area from existing lines of adequate capacity.

Applicability

Applicable for service to irrigation pumping motors of 15 horsepower or greater, delivered at one point on the member's premises and supplied through one meter, subject to the established Service Rules and Regulations of the Corporation.

Pumps of less than 15 horsepower served under rate schedule IS-8 will be permitted on this schedule. No new accounts less than 15 horsepower will be furnished service hereunder.

Type Of Service

Single-phase or three-phase, 60 Hertz, at available secondary voltages, subject to the Corporation's line extension and rephasing policy contained in this Schedule and in the Service Rules and Regulations of the Corporation.

Annual Rate

A. Service Charge @ \$75.00 per year

B. Capacity Charge @ \$18.05 per Hp per year

C. Energy Charges:

All On-Peak Energy @ 14.5¢ per kWh

All Off-Peak Energy @ 9.0¢ per kWh

D. WPCA - The above rate charges shall be increased or decreased in accordance with the Corporation's Wholesale Power Cost Adjustment Clause.

Determination Of On-Peak And Off-Peak Energy

The On-Peak Energy shall be all kilowatt-hours used by the consumer during the on-peak hours beginning at 4:00 p.m. and ending at 9:00 p.m. from June 1 through September 30 and will exclude weekends (Saturdays and Sundays).

Off-Peak Energy shall be kilowatt-hours used by the consumer during all hours other than on-peak hours as described above.

Minimum Annual Charge

The minimum annual charge shall be the sum of the service and capacity charges stated above.

The member's obligation to pay the full minimum annual charges herein shall not be diminished by discontinuing use of such service during June through May of the contract year (this twelve-month period is referred to herein as the "irrigation contract year").

Any application for reconnection of service at any later date shall obligate the member to pay the sum of any accrued charges applicable to the irrigation contract year during which service was discontinued.

Determination Of Horsepower

The horsepower for billing purposes shall be the greatest of the following:

- A. The contract horsepower, or
- B. The manufacturer's nameplate rating of horsepower output, or
- C. The horsepower determined by actual measurements made by the Corporation of the power input during a period of maximum normal use, or
- D. The highest thirty-minute kilowatt demand measured during the current month, provided however, that such demand shall not be less than the highest such demand established to date during the current irrigation contract year.

Line Extension Costs

The amount specified under the line extension and rephasing policy contained in the Service Rules and Regulations of the Corporation, such amount to be provided by the member in a manner specified in that policy.

Terms Of Payment

Bills are due when rendered monthly. In the event the current monthly bill is not paid within fifteen days of the billing date, the bill becomes delinquent.

The Service Charge and Capacity Charge shall be billed in three equal monthly installments in June, July, and August of each year whether or not energy is actually used during the irrigation contract year.

When service hereunder is first made available, the member will be billed a prorated Service Charge and Capacity Charge based on the number of billing days between the availability of service and the next June. The prorating will be based on the number of days remaining in the irrigation contract year and will be billed on the member's first statement rendered after service is available.

Term Of Contract

A formal contract will be required between the Corporation and the member with a specified service period set forth therein; provided, however, that the contract shall be renewed in twelve-month periods after the end of the initial contract period, unless either party gives the other twelve months advance notice in writing of his intention to terminate service.
